Subject: Grant of permission for study leave.

In pursuance to Rule-73(ii) of J&K Civil Services (Leave) Rule 1979 as amended vide SRO-274 of 2013 dated 30.05.2013, sanction is hereby accorded to the grant of Study Leave for two years w.e.f 04.09.2017 in favour of Mr. Ankit Kumar, Fitter, PHE City Division-I, Jammu for pursuing Diploma in Civil Engineering for pursuing three years Diploma Course in Civil Engineering through Lateral Entry from the Aman Bhalla Institution of Engineering and Technology, Pathankot, Punjab subject to the following conditions:-

- i. The diploma will be a higher qualification to Mr. Ankit Kumar, Fitter which would be an added feather to him and can prove beneficial to the department, if required;
- ii. Although there is no dearth of diploma holders but his services can be utilized afterwards, if required.
- iii. The work load on account of proceeding on study leave by him shall be managed through internal arrangement by the Chief Engineer, PHE Jammu and no substitute shall be provided to him;
- iv. After acquiring diploma in Civil Engineering, he shall have no superior claim over his seniors for consideration of his promotion or otherwise except as provided under rules;
- v. The diploma to be obtained by the official can prove beneficial to the department, if he shall deliver the goods after qualifying the same.
- vi. The stipened, scholarship etc, if any, received during the study leave by the official shall be adjusted in his leave salary;
- vii. A certificate shall be furnished by the official from Aman Bhalla Group of Institute Pathankot, that the institution as well as the diploma to be obtained by the candidate is recognized by AICTE.

- viii. The candidate namely Mr. Ankit Kumar S/o Ramesh Kumar, Fitter shall undertake that after successful completion of the diploma, he will serve the department of PHE and if not he will indemnify all the expenses to the department incurred on him for undergoing study leave.


