Approval is hereby accorded to the revised DPR costing Rs. 4,750.00 crore (Rupees four thousand seven hundred and fifty crore only) for construction of Ujh Multipurpose Project, with the following features:-

i. Maximum water level	= 609.50 m
ii. Full Reservoir Level	= 608 m
iii. CFR Dam height	= 116 m
iv. Max installed capacity ( power)	= 186 MW
v. Revenue villages affected	= 2 fully, 10 partially
vi. Land affected	= 34.50 sq. Km.
vii. Houses affected	= 1,698
viii. Population under submergence	= 8,684 souls

The approval is further subject to the conditions that:

- Ownership rights over the project will vest with the J&K Government.
- The project will be funded by Government of India in the ratio of 90:10;
- Government of India will suggest a PSU for the implementation of the project; and
- Relief and Rehabilitation Plan for project affected families/ utilities of the Departments etc on the pattern of one implemented in respect of Kishenganga Hydroelectric Project shall be part of the project which will be implemented under the aegis of the Disaster Management, Relief, Rehabilitation and Reconstruction Department in the State Government.

This is in partial modification of Government order No. 321-PW(Hyd) of 2017, dated 11.08.2017, issued on the subject.
