Sanction is hereby accorded to the release of central assistance of Rs. 123.43 lacs (Rupees One crore Twenty Three lacs and Forty Three thousand only) out of 1st installment of 2011-12 released by the Ministry of Rural Development, Department of Drinking Water & Sanitation, GOI vide their sanction No's:- W-11020/10/ 2011/ NRDWP/Water/182 dated 22-12-2011 under NRDWP (WQM&SP) through cheque bearing No: 091330 dated:- 09-10-2013 & No: 091331 dated:- 09-10-2013 drawn on the J&K Bank Moving Secretariat Srinagar for an amount of rupees Sixty Six lacs in favour of the Chief Engineer, PHE Deptt. Jammu (Rs 66.00 lac) and for an amount of rupees Fifty Seven lacs and Forty Three thousand only in favour of Chief Engineer, PHE Deptt. (Rs. 57.43 lacs) respectively for establishment of Water Quality Labs during the year 2013-14, as per the Uniform Drinking Water Quality Monitoring Protocol under NRDWP..

The release of Central assistance is subject to the conditions that :-

- i) these funds shall be utilized after observing all codal formalities besides strictly adhering to the guidelines of NRDWP(WQM&SP)/ Uniform Drinking Water Quality Monitoring Protocol and no deviation shall be made;
- ii) the CE shall ensure that funds are further released to implementing agencies within 7 days from the date of issuing of this order with a copy to the Adm. Deptt.;
- iii) the CE shall ensure that funds are further released for those components/works only which fall within the ambit of guidelines;
- iv) there shall not be any duplication in incurring of expenditure to obviate any chance of misuse of funds;
- v) all quality parameters /specifications shall be strictly adhered to, to ensure optimum utilization of funds;
- vi) the CE shall incur the expenditure under following classification for proper accounting:
