- II. No work should be taken in hand, in anticipation of accord of Administrative Approval/ technical sanction by competent Authority;
- III. The funds shall be utilized strictly as per the Scheme-wise Action Plan approved by the SLSSC held on 12-6-2013;
- IV. There shall not be any duplication in the adoption of works / schemes and incurring of expenditure thereon to obviate any chance of misuse of funds;
- V. No diversion of funds from one scheme to another is allowed without prior approval of the Adm. Deptt.

- VI. The DSE shall ensure that no new schemes are taken up out of the funds released which have not been approved by the Scheme Level Scheme Sanctioning Committee(SLSSC) besides revision of cost of schemes is not allowed;
- VII. The funds shall be further released, immediately to the implementing agencies in proportion to the current years scheme-wise allocation to ensure its utilization and achievement of targets with intimation to the Adm. Deptt.
