Subject: Cancellation of appointment as Draftsman (Civil) in PHE/I&FC Department and operation of waiting list thereof.

Whereas, vide Government Order No.301-PW(Hyd) of 2016 dated 21.10.2016 issued under endorsement No.PW/PHEK/NGJ/92/2013 dated 21.10.2016 among others Mr. Sunny Bassan S/o Muni Lal R/o Kunjwani, Jammu was appointed as Draftsmen (Civil) under SC category and directed to report Chief Engineer, RTIC Jammu for further posting/adjustment within 21 days from the date of issuance of the order; and

Whereas, the Chief Engineer, RTIC, Jammu vide letter dated 18.11.2016 has intimated that Mr. Sunny Bassan S/o Muni Lal R/o Kunjwani, Jammu who was appointed as Draftsmen (Civil) under SC category has not joined despite the lapse of stipulated period of 21 days of joining; and

Whereas, the case was examined in the department and Chief Engineer, RTIC, Jammu vide letter dated 22.02.2017 was requested to serve notice to Mr. Sunny Bassan who have not joined till date; and

Whereas, Chief Engineer, RTIC Jammu vide letter dated 18.03.2017 has intimated that a final notice was served to Mr. Sunny Bassan S/o Muni Lal R/o Kunjwani, Jammu vide his office letter No.RTIC/Estt/5360 dated 04.03.2017 to join the service but he has not joined. However, he had submitted a representation on 14.03.2017 mentioning therein that he is already serving in other department and not willing to join the post of Draftsman (Civil) in PHE/I&FC Department. In this regard he had submitted undertaking on an affidavit duly attested by the Ist. Class Magistrate; and

Whereas, the case was further examined and referred to General Administration Department for their expert opinion with regard to operation of wait list after the expiry of one year; and

Whereas, the General Administration Department vide U.O No.GAD/Mtg/RB-IV/03/2017 dated 31.05.2017 has advised the department to submit a note to the Hon'ble Chief Secretary in Coordination for relaxation of sub-rule 7 of Rule-14 of the J&K Civil Services Decentralization and Recruitment Rules, 2010 for re-validation/extension in operation of wait list in favour of Mr. Gurcharan Lal, figuring in the wait list at Sr. No.1 under SC category for the post of Draftsman (Civil) Divisional Cadre, Jammu and in the meanwhile cancel the appointment order of Mr. Sunny Bassan.

Whereas, the case was again examined and vide order No.272-PW(Hyd) of 2017 dated 11.07.2017 the department cancelled the appointment of Mr. Sunny Bassan, S/o Shri Muni Lal R/o Kunjwani, Jammu as Draftsman (Civil) made vide Government Order No.301-PW(Hyd) of 2016 dated 21.10.2016 and subsequently submitted a note to the Chief Secretary in Coordination for relaxation of sub-rule 7 of Rule-14 of the J&K Civil Services Decentralization and Recruitment Rules, 2010 for revalidation/extension in operation of wait list in favour of Mr. Gurcharan Lal, figuring in the wait list at Sr. No.1 under SC category for the post of Draftsman (Civil) Divisional Cadre, Jammu.

Whereas, the General Administration Department vide OM No.GDC-217/CM/2017 dated 26.10.2017 conveyed approval of the Hon'ble Chief Minister which reads as under:-

"Sanction is hereby accorded, in relaxation of sub rule (7) of Rules 14 of Jammu and Kashmir Civil Services Decentralization and Recruitment Rules to the revalidation of waiting list for the post of Draftsman (Civil) Divisional Cadre, Jammu recommended by the Service Selection Board vide their letter No.SSB/Secy/Sel/2016/8062-68 dated 05.04.2016 in respect of 01 candidate namely Mr. Gurcharan Lal S/o Girdhari Lal R/o Tapyal Samba, of SC category against Item No.046 of Advertisement Notice No.01 of 2013 beyond the date of its expiry (viz. 04.04.2017) upto 30<sup>th</sup> November, 2017".

Consequent upon the above, sanction is accorded to the appointment of Shri Gurcharan Lal S/o Shri Girdhari Lal Tehsil Tapyal, Samba figuring at S.No.01 of the wait list under SC Category against item No.046 of Advertisement Notice No.01 of 2013 as Draftsman (Civil) in the pay band of Rs. 5200-20200 with grade pay of Rs. 2400 in PHE/I&FC Department.

The appointee shall be on probation for a period of two years and shall be allowed to join only on production of the following certificates/documents in original:-

- I. Education Technical Qualification Certificate/marks sheets which will also include whether technical degree/ diploma is approved for employment in J&K.
- II. Date of Birth Certificate/Qualification Certificate.
- III. Permanent Resident Certificate/State Subject.
- IV. Age and Health Certificate issued by an officer not below the rank of Chief Medical Officer.
- V. Character and Antecedents Certificate.
- VI. Certificate from concerned authorities to the effect that no loan under Self Employment Scheme has been obtained/availed by the concerned candidate.
- VII. Reserved Category Certificate.
- VIII. Any other relevant certificate as required under rules.

Consequent upon his appointment, he shall report to the Chief Engineer, I&FC Jammu for further duties within a period of 21 days from the date of issuance of this order. If he fails to do so, his appointment shall be treated as cancelled ab-initio.

Further, the above appointment is provisional and subject to the following conditions:-

- a) The Chief Engineer, I&FC shall personally verify the genuineness of institution and qualification Certificate/Category Certificate/ Permanent Resident Certificate and all other documents under rules. It shall purely be the responsibility of Chief Engineer to verify the genuineness of all the documents by following the due procedure of law. If any adverse report with respect to any of documents as mentioned above shall come to the notice of the department in respect of

appointee at the later stage then the responsibility shall be upon the concerned HOD.

- b) The appointee shall give an undertaking in the shape of an affidavit that in case any adverse report about his character and antecedents is received from the Additional Director General of Police, CID, J&K to whom reference shall be made by the authority to whom he shall submit his joining report or any other adverse report about his qualification etc, the candidate shall have no right to claim his appointment as Draftsman (Civil) and his appointment as such shall be deemed to be void-ab-initio and cancelled as such.
- c) Salary of this appointee shall not be drawn and disbursed to him unless satisfactory character and antecedents report is received from the ADGP, CID and verification of genuineness of his qualification/category and any other certificates it received from the concerned authorities.

The appointment of above mentioned candidate will not come under the purview of new Recruitment Policy notified by the General Administration Department vide SRO-202 of 2015 dated 30.06.2015 and while as the inter-se-seniority of the appointee shall be in order of merit as per the selection list furnished by the J&K SSB.

This order is issued subject to outcome of writ petition(s), if any, pending in any Court of Law of competent jurisdiction.
