NOTICE

Whereas, 44 vacancies of Junior Assistants (Divisional Cadre Jammu) were referred to J&K Services Selection Board vide letter No:PW/Hyd/Adm/08/08 dated 20.01.2011.

Whereas, the said vacancies were advertised by the Services Selection Board vide advertisement notice No:01 of 2011 dated 31.01.2011 at Item No.101.

Whereas, Secretary, J&K Services Selection Board Jammu forwarded a select list of candidates for the posts of Junior Assistant (Divisional Cadre Jammu) vide his letter No:SSB/Sel/Secy/014/1237-42 dated 25.02.2014 and letter No: SSB/Sel/Secy/014/1642-43 dated 05.03.2014. The said list was published in Daily Excelsior on 27.02.2014 and also put on the official website of J&K Services Selection Board.

Whereas, the Department vide Government Order No:112-PW(Hyd) of 2014 dated 05.03.2014 issued Appointment Orders in favour of 36 Junior Assistants with the condition that the appointees shall report to Chief Engineer, I&FC Jammu and Chief Engineer, RTIC Jammu within 21 days from the issuance of the appointment order. It was further mentioned that if any appointee failed to do so, his/her appointment shall be treated as cancelled ab-initio.

Whereas, Chief Engineer I&FC Department Jammu vide his letter No:IFCJ/E/24382 dated 29.03.2014 intimated that out of 26 appointees only 08 appointees have joined within the stipulated time and Chief Engineer, RTIC Jammu has also intimated vide his letter No:8033-34 dated 26.03.2014 that out of 10 appointees, only 02 have joined in his office within the stipulated time.

Whereas, the Department intends to operate waiting list already furnished by SSB and subsequently intends to issue appointment order in favour of 07 candidates in waiting list of Open Merit category. Before doing so, objections if any, may be submitted to this Department within a period of 10 days from the issuance of this Notice failing which no objections would be entertained later on.


