In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 dated.22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Mushtaq Ahmad Bhat S/o Late Mohd Akram Bhat (Ex-Coolie) R/o Kachwari, Tehsil Khansahib, District Budgam, as Chowkidar (Class-IV) in the Pay Band of Rs.4440-7440 with the Grade Pay of Rs.1300/- in the Irrigation & Flood Control Department, Kashmir in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Chief Engineer, Irrigation & Flood Control Department, Kashmir, within 21 days from the date of issuance of this order and shall be allowed to join only on production of the following certificates/documents in original:-

1. Academic Qualification Certificate.
2. Age and Health Certificate.
3. Permanent Residence certificate.
4. Any other relevant document, as required.
5. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointee shall be on probation for a period of two years. The Chief Engineer, Irrigation & Flood Control Department, Kashmir shall get the certificates/other documents of the candidate verified from the issuing authorities.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, (CID) to whom a reference shall be made by the Chief Engineer, Irrigation & Flood Control Department, Kashmir. If, on verification, the certificates/documents produced are proved to be fake or forged or the verification report about his character and antecedents is received as unsatisfactory, the appointment shall be cancelled abinitio.


