In continuation to Govt. Order No. 224 - PW (Hyd) of 2019 dated 14.06.2019, sanction is hereby accorded to the release of funds to the tune of Rs.400.00 lakh (Rupees four crore only) under Capex Budget 2019-20 and placement of the same at the disposal of Chief Engineer I&FC Kashmir for purchase of (02) No. Cutter Suction Dredgers including discharge pipes and floaters.

The release of funds is subject to the following conditions:-

- a) That in accordance with the Appropriation Act, the funds will be released through BEAMS and the Chief Engineer shall further release the funds through BEAMS;
- b) That the purchases shall be made on strict and transparent e-tendering basis and as per standing guidelines governing purchases for Government Department;
- c) That the funds shall be utilized after observing all requisite codal procedures /norms;
- d) That the funds shall not be available for re-appropriation/diversion at any level;
- e) There shall be no expenditure on revenue or revenue like items;
- f) That the funds should not be parked un-necessarily;
