Subject:-Release of Central Assistance under (Support Activity) NRDWP during 2017-18.

Sanction is accorded to the release of funds to the tune of Rs. 20.00 lacs (Rupees twenty lakh only) in favour of the Executive Director, CCDU for carrying out Support Activities as per approved Annual Action Plan 2017-18. The funds so released shall be transferred electronically in to the bank account No. 1112040500000003 maintained by the Executive Director, CCDU, J&K at J&K Bank, Polo View, Srinagar.

The release of Central Assistance is subject to the conditions that :-

- i) Executive Director shall utilize the funds during 2017-18 strictly as per Annual Action Plan 2017-18;
- ii) That the decisions of the SLSSC/WSSO shall be strictly adhered;
- iii) All the activities / items for which the payment is to be made has been approved by the Divisional Level Committees/ approved in AAP/competent authority.
- iv) Executive Director shall satisfy himself/herself about the reasonability of costs & genuineness of claims.
- v) The photographic and video graphic evidence of the activities undertaken shall be obtained and kept in record.
- vi) Due diligence is effected & thorough analysis is done to ensure that economy is achieved while making the payments and the claims shall satisfy the touchstone of reasonability of costs, so that State exchequer is benefitted.
- vii) The funds so released shall be utilized for the specified purpose after completing all the codal formalities/ procedures as required under rules/guidelines of the programme and shall not be available for re-appropriation/ diversion at any level.
- viii) Utilization Certificates for the amount utilized shall be furnished immediately to the Adm. Deptt.
