Sanction is hereby accorded to the release of additional funds to the tune of Rs. 62.00 lakhs (Rupees sixty two lacs only) under Capex Budget 2018-19 after RE in favour of Chief Engineer I&FC Kashmir for its utilization during current financial year for clearance of work done claims for Flood Protection Works by Flood Control Division, Anantnag .

The release of funds is subject to the following conditions:-

- That in accordance with the Appropriation Bill, the funds will be released through BEAMS and the Chief Engineer shall further release the funds through BEAMS;
- That the funds shall be utilized for specific purpose after observing all requisite codal procedures including AAA/TS from competent authorities and ascertaining the genuineness of the claims;
- That proper and transparent e-tendering process is adopted in the execution of works & purchase of material/equipment;
- That the responsibility of verifying the genuineness of claims and fulfilment of all codal formalities including audit, verification and on ground checking shall vest squarely with Chief Engineer I&FC Kashmir who will ensure that the needful is done before releasing the payment;
- That the work shall be completed within the approved cost and prove to be beneficial to the general public;
- That the funds should not be parked un-necessary;
- That there shall be no overlapping of funding from any other source including Languishing projects funded through JKIDFC; and

- (h) That the funds so released shall not be available for re-appropriation/diversion at any level;


