Whereas, the final seniority list of Superintending Engineers (Civil) of Hydraulic Wing was last issued vide Government Order No. 385-PW (Hyd) of 2007 dated 12.12.2007; and

Whereas, on the recommendations of the Departmental Promotion Committee/ J&K Public Service Commission, vide Government Order No. 61-PW (Hyd) of 2014 dated 10.02.2014 and 309-PW (Hyd) of 2014 dated 07.08.2014, sanction was accorded to the regularization of Executive Engineers as Superintending Engineers from retrospective dates; and

Whereas, the above changes have necessitated the issuance of the seniority list of the Superintending Engineers afresh; and

Whereas, the tentative seniority list of the Superintending Engineers was issued vide Circular No. 01-PHE, I&FC (Hyd) of 2015 dated 19.02.2015 for calling objections, if any, within a period of 21 days from the date of publication of the circular. In the said tentative seniority list, it was provided that the seniority of the Incharge Superintending Engineers, in whose favour regularization/promotion as Superintending Engineers has been deferred due to directions from the Hon'ble Court shall be reflected at suitable places in the seniority list later on once they are regularized after obtaining requisite clearance on case to case basis and subject to final outcome of writ petition(s) pending in the Hon'ble court(s); and

Whereas, no objections have been received, either directly in the administrative department or through the Chief Engineers within the stipulated time.



Now therefore, the final seniority list of the Superintending Engineers (Civil), PHE and I&FC Department as it stood on 01.01.2012, forming annexure to this Government Order is hereby issued. Seniority positions assigned to the members shall be without prejudice to the final outcome of the writ petition(s), if any pending before any competent court of law. The dates of birth of the members recorded in the final seniority list shall not be taken as the authentic and shall be subject to the verification from the original Service Books/ Matriculation Date of Birth Certificates of the concerned officers.
